The UENHA membership directory has contained a *condensed* version of the deed restrictions (covenants) for University Estates North (UEN). These establish rules or regulations set by the original property developer that pertain to your home with an intent to enhance and maintain the value of that property. UEN was platted (subdivided into lots showing the location and boundaries of individual parcels with the streets, alleys, easements, and rights of use over the land of another) into four separate development phases, #3, #4, #5 and #6. The covenants of these separate phases can be viewed online at the Dallas County Clerk website (dallas.tx.publicsearch.us/) by their respective documents, #3 – Document 197800584299, #4 – Document 198000381917, #5 – Document 198100603122, and #6 – Document 198301391058. A copy of your relevant covenant should be included with your legal documents addressing your property.

The construction phase plats, filed with Dallas County, can also be viewed online using the following document numbers: #3-197700704016 & 197700888947, #4-197900861247 & 197901725843, #5-198000705980 & 198000403771, and #6-198101014903.
